I understand that I will provide foster care for the above rescue animal from Eastwood Ranch Foundation (ERF) at no charge, and I agree to the following conditions during the foster care period:

- 1. I will accept and consider the pet as an indoor household companion, not as an outside pet, and will provide the dog/cat with a safe environment, humane treatment, and give proper food, fresh water, shelter and exercise, and I will allow a reasonable amount of time for the pet to adjust to new surroundings.
- 2. **ERF** will cover veterinary expenses for the pet, provided that the veterinary care is pre-approved by the **ERF** Director and performed by an **ERF** authorized veterinarian. **ERF** will not reimburse for any medical care unless it is pre-approved by the **ERF** Director and performed by an **ERF** authorized veterinarian.
- 3. I will immediately notify **ERF** if the dog/cat is lost or stolen, and I will make every reasonable effort to recover the pet.
- 4. I will NOT give or sell the pet to another person, relative, or any other individual, or any rescue group, humane association, shelter or pound, or any medical or experimental laboratory or any organization.
- 5 I will immediately notify **ERF** in the event of the animal's death during the foster care period.
- 7. I will allow an **ERF** representative to make periodic visits to my home during the foster care period.
- 8. I will immediately notify **ERF** of any change in address or telephone number, or of any plans to move or travel with or without the pet.
- 9. I will immediately notify **ERF** of any change in circumstances that may prevent me from providing foster care during the time period agreed upon under this foster care agreement.
- 10. I will immediately return the pet in good condition to **ERF** if at any point and for any reason **ERF** requests that I surrender the pet.
- 11. Should I decide to permanently adopt the dog/cat, I will notify **ERF** and, upon approval will follow established adoption procedures.
- 12. I understand that the pet has been vetted, checked, spayed/neutered and vaccinated by a licensed veterinarian and that the animal's health is accurately represented to the best knowledge of **ERF**. However, I further understand that no representations are made by **ERF** as to the temperamental or mental disposition of the animal.
- 13. I agree to foster the pet at my own risk, and indemnify and release **ERF**, its Officers, Directors, and volunteers, of any and all liability arising from damages to person(s) or property caused by the animal.
